Dear Parents and Carers,

I am writing to highlight the significant issue we, as a school community, are facing in regards to attendance. Currently our whole school attendance rate is 95.3 %, which is a drop from the preceding year.

Our current situation places us with a concerning attendance rate. The whole school community: governors, SLT and teaching staff, support staff, Local Authority and parents would really like to see this attendance rate flourish. The government also deems this to be below an acceptable figure. A child should attend school every day and attendance over 96% is considered to be good attendance. If attendance drops to 90% or lower, the government classifies the child as having persistent absence (PA), and if attendance is 50% or less, the child is classified as severely absent (SA). A child with 89% attendance at the end of an academic year will have missed 21 days of school (which is over four school weeks of learning missed).

I wanted to highlight through the table below the impact of poor attendance to show the amount of lost learning it equates to. When a child does not attend school, they miss out on significant hours of learning opportunities (broadly calculated as five hours for every two sessions missed) which are unlikely to be covered again. Imagine missing 4 weeks of daily phonics or Week 1 of 'Fractions', for instance, that child will forever be on the back foot or playing catch up, and places them at a significant risk of falling behind their peers:

For those children whose attendance falls below 91%, their parents will be invited in to discuss their attendance and ways in which we can support to improve this.

We will obviously take into consideration pupils with long term diagnosed medical conditions/disabilities.

I would also like to notify you that the school will be issuing fixed penalty notices for persistent unauthorised absences where appropriate. The school would look on this as a last resort, as we would much prefer to work together with families to ensure children maintain good attendance and benefit from the opportunities offered to them at school. We do understand the cost-of-living crisis is impacting families who are keen to get away on an affordable holiday, however, we cannot condone absences of this type.

I appreciate this may come across negatively to some families. However, we collectively have a responsibility to ensure strong attendance across the school. I know that working together we will be able to improve the attendance of our children so that they can meet their full potential.
